NEBRA custodial role

- National Biosecurity Committee agreed that the Commonwealth will lead an approach to market for the services of a NEBRA custodian
 - If an appropriate body identified, a contract for 5 years would be available and funded through the signatories to the NEBRA
 - Further detail on contract/custodian deliverables is pending public commencement/availability of the tender process
- In the interim PHA has been exploring the potential benefits and risks in seeking this project
- PHA Board supports in principle PHA seeking this project subject to member consultation and further clarification of the role
- Feedback and support from members on this important project is being sought



Key points

- Externally (non-subscription) funded, project for a set duration
- Appropriate level of funding/resources would be required for PHA to accept project
 - Focus on primary EPPRD matters would not be compromised at any level
 - Level of staffing/funding required will be informed by tender process (once released)
- Wider platform to highlight and engage on plant biosecurity issues
- Opportunity to increase member profile and that cross-sectoral interest in biosecurity

Key points

- Plant industries would have a stronger voice in national issues impacting on them
- Greater level of coordinated and collaborative emergency preparedness/training activities
- Closer, more robust and constructive relationships between all stakeholders






2019/20 Forecast – Income (\$m)






2019/20 Forecast – Equity (\$)








Total PHA levy payments received by Year

DRAFT SUBSCRIPTIONS FOR 2020/21



- Based on formulas in the PHA Constitution
- Average Local Value of Production (LVP) for three years 2015/16, 2016/17, and 2017/18)
- We are required to use published Local Value of Production (LVP) figures from an approved Statutory Authority which is:
 - the Australian Bureau of Statistics (ABS); or
 - if a required statistic has not been published by the ABS, the Australian Bureau of Agricultural and Resource Economics and Sciences (ABARES); or
 - if a required statistics has not been published by either the ABS or ABARES, a source of the required statistic as determined by the Directors.



- The Annual Subscription of an **Associate Member** shall be determined by the Directors from time to time.
 - Last increase was in 2011/12 to \$2,000.
 - Reaffirmed at BM97 on 26 February 2020
- Minimum Subscription means the minimum Annual Subscription determined by the Directors from time to time.
 - Has been \$1,500 since inception of PHA.
 - Reaffirmed at BM97 on 26 February 2020



- Feedback from members is critical for PHA to facilitate meeting
 Member requirements from within current resources
- Subscriptions were last increased by 1.3% (CPI) for 2019/20
- Draft 2020/21 Subscriptions have **not** increased
- Dependent on Member feedback, our aim is to present a balanced budget for 2020/21 at the May 2020 General Meeting



Movements in subscriptions for 2020/21 compared with 2019/20 are also due to:

- shifts in Local Value of Production (LVP) for different <u>industries</u> which, in turn, affects the relative proportion of individual Member subscription shares calculated in accordance with the three-year rolling average subscription formula set out in the PHA Constitution
- shifts in Local Value of Production (LVP) for each <u>State and Territory</u>
