Introduction to Protected Cropping Australia (PCA)

Mission: PCA represents the protected cropping sector in Australia, advocating for high-value crops grown in controlled environments such as greenhouses, poly-tunnels, and vertical farms.

Core Focus Areas:

- Advocacy: Engaging with government and industry to represent the sector's interests.
- Research & Development: Partnering with institutions like Hort Innovation Australia (HIA), RMIT, and Applied Horticultural Research (AHR) to advance sustainability and strengthen biosecurity.
- **Education & Training**: Providing members with resources, workshops, and programs with support from experts such as Tony Bundock, Alistair McLean, and Andrew McIlwain to keep growers informed on best practices.
- Networking: Fostering connections among growers, suppliers, and researchers to drive innovation and industry growth.



August 2024: Immediate Response to ToBRFV Outbreak

Detection and Emergency Response

- On detection of ToBRFV in South Australia, PCA led an emergency meeting for growers and stakeholders.
- We acknowledged our shortcomings and the importance of being members of the EPPRD and broader Biosecurity community.
- We prioritised strategies for containment, economic impact minimisation, and communication.

EPPRD Membership Application

Aimed at securing:

- Representation in biosecurity decision-making.
- Access to future Owner Reimbursement Costs (ORCs) for pest treatment and crop destruction.
- Collaborative cost-sharing models to support sustainable pest responses.

Industry Collaboration:

 We have actively communicated with HFF, IFPA, AUSVEG, PIRSA, Fresh Tomatoes', Field Growers, Nursaries and other organisations to advocate for national alignment in biosecurity strategies.



Strengthening Biosecurity and Research Initiatives

Research Collaborations:

 Ongoing Partnerships with RMIT, Hort Innovation, and AHR to advance pest management, disease resistance, and water efficiency.

National Biosecurity Representation:

- Pursuing membership in EPPRD and other biosecurity bodies to ensure the sector's needs are prioritised.
- Advocating for science-based approaches to market access and quarantine measures.

Proposed Initiatives:

- Introducing a sector-specific biosecurity levy to fund rapid responses and innovation.
- Exploring public-private insurance models to mitigate financial losses during biosecurity crises.
- with the government, promoting sustainable pest response measures



The Case for PCA's EPPRD Membership

Current Challenges:

- Limited inclusion in biosecurity discussions has exacerbated growers' financial and operational challenges.
- Fragmented quarantine measures have disrupted trade and market access.
- Lack of communication with growers has created an environment of fear to the detriment of open disclosures of potential infection.

Key Benefits of Membership:

- Representation in biosecurity decision-making ensures growers' voices are heard.
- Access to cost-sharing frameworks and financial support for emergency responses.
- Enhanced collaboration with government and industry to safeguard the sector.

• Granting PCA observer status to enable immediate participation while the membership process is finalised.

- PCA is committed to fostering resilience, growth, and innovation in Australian agriculture.




PHA income


2024-25 Forecast \$14,873,281


■ Q1 Expenses ■ FY25 Forecast


Breakdown of expenditure (Q1)
